Minutes of the Meeting of the Property Committee held in the Council Chamber, Yaxley Parish Council on 21st March 2017.

PR35. APOLOGIES

Apologies for absence from the meeting were received and accepted on behalf of Councillors C Bolton (work commitments) K Gulson (personal) and C Thorne (personal).

PR36. DECLARATION OF INTERESTS

No declarations were received.

PR37. MINUTES

Councillor J Willis proposed approval of the Minutes of the Committee held on 15th November 2016. This was seconded by Councillor J Lusted and unanimously **RESOLVED.**

PR38. PUBLIC PARTICIPATION

No Member of the Public wished to speak.

PR39. EXTENSION TO EXISTING OFFICE

In noting that the office extension was on target to be finished by the end of March, Members thanked all those involved in its construction.

PR40. SOLAR PANELS

The Clerk reported that the solar panels should be signed off this week.

PR41. REPAIRS AND MAINTENANCE

Members' attention was drawn to a schedule of maintenance work carried out on the Council's facilities since their previous meeting and that planned for the next 3 months. Particular mention was made of the work to concrete the entrance to the compound and repairs to the gable end of the scout garage. With regard to the latter, Councillor P Russell agreed to speak with the scouts over the emptying of the garage.

PR42. LEGIONELLA MONITORING

Attention was drawn to a proposed programme of monitoring for legionella (a copy of which is appended in the Minute Book) produced by Hydraclean. In discussing its contents, Members were advised of the views of Councillor Bolton which he had submitted prior to the meeting by email. Councillor Bolton was of the opinion that the quote be used as a basis of requirements for moving forward, but that another quote be obtained and members of staff undertake training to enable the majority of work to be undertaken in house.

In the discussions that ensued, the Committee questioned what the legal requirement was for the Council's facilities and various Members agreed to investigate what is required. In the meantime the Clerk would obtain another quote.

PR44. FAIR RENT REVIEW

By way of a report by the Clerk (a copy of which is appended in the Annex to the Minute Book), Members were given the background to a previous application for a fair rent review on 50 Main Street, Yaxley. Whereupon, it was proposed by Councillor S White that legal advice be taken over the options available to the Parish Council regarding the renting out of this property. This was seconded by Councillor M Oliver and unanimously **RESOLVED.**
