We also look forward to more information on the trees to be planted on site which mirrors the concerns of the local tree officer.
22/00690/FUL	Single story front extension: 3 Chapel Street Yaxley Peterborough	The Parish Council supports the application.

22/00721/FUL	Proposed single dormer window to front (North East) elevation to replace 2no existing dormer windows. Proposed single storey rear extension: 1 Windsor Road Yaxley Peterborough	The Parish Council supports the application.
22/00985/FUL	Alteration to shop front and existing roller shutters upgraded (retrospective): 93A Main Street Yaxley.	The style and design of the alterations are not in keeping with the conservation area or street scene. The original facade and corbelling detail is lost under the 8 m sign. The sign sticks out over the edge of the building so much that the shops own delivery wagon frequently hits it.
