The surface water drainage map states that the downstream pipe is expected to be upsized as part of the Yaxley Road Scheme by the adjoining developer, outfall length of existing watercourse to be reconfigured to outfall into existing headwall adjacent to A15 London Road. The design details of the Eastern Vortex flow control chamber refers to an overflow rate of 32 litres per second. There appears to be no concern as to where the water is going to end up or whether the system is big enough to take it. Relying on an expectation that the adjoining developer or Highways will upsize the pipes is not good enough. The surrounding area recently experienced flooding from this site, after surface water was pumped from this site and allowed to run down Waterslade Road and Church Street, flooding gardens. The Parish

		Council has met with Kathryn Reading, Senior Flood Risk Officer with Cambridgeshire County Council over this and has stressed that directing the water towards the A15 and Waterslade Road can not be the final solution.
