23/00141/HHFUL	Change of Use of Land to part residential / part landscape buffer, with replacement garden fence : 16 Cock Close Road Yaxley	The Parish Council objects to this application for the following reasons: loss of open space, the landscaping designs of the original planning application for the estate required these open spaces and there loss would be detrimental to the area; loss of street scene, the character of the estate would be lost; and extending the fence would set a precedent for others and would result in a disjointed arrangement not in keeping with the area. A previous application to move a fence (17/00877/FUL) on another area of open space on this housing development was		

recommended for refusal by the Parish Council and was subsequently withdrawn by the applicant. The Parish Council are concerned that works to clear the area have already commenced, in advance of any planning permission being granted, and we would request that the area is reinstated to it's original condition by whichever party cleared the site. we would also point out that the plan attached to the application is incorrect, although it does show where the fence line should be (marked as existing post and rail fence) the fence has already been moved including an area of fence line at the front of the property and we ask that it be put back to its original position.
